Sun Coast Converters, Inc.(SCCI) assemblies with torque converters are warranted to be free from defects in material and workmanship to the original purchaser/end user for a period of 36 months. This warranty shall terminate at the 3 year anniversary date from the time of the original invoice. SCCI reserves the right to amend this warranty at any time. SCCI's liability under this warranty is limited to repair or replacement, at its option, subject to the provisions set forth herein of any parts, which upon examination by SCCI, are found to be defective. SCCI reserves the right to determine the course of action in regard to repair and/or replacement of any and all warrantable products and/or services.

During the first 12 months of warranty, SCCI will arrange shipping and will reimburse R&R labor charges not to exceed \$350 for Ford/Dodge and \$450 for GM/Chevy vehicles. This reimbursement will be made only to an authorized automotive repair facility provided that the original installation was performed by an approved SCCI Installation facility. After the first 12 months of the warranty, SCCI will cover parts cost only for the remaining 24 months of warranty. Any labor and shipping costs after the first 12 months of the warranty will be the responsibility of the customer. The warranty does not cover fluids and filters. Third party electrical components are warranted for 90 days from original invoice date. Any part submitted for warranty consideration must be returned to SCCI, accompanied with a copy of proof of purchase (invoice), a description of the concern/complaint, and service history records. Repaired or replaced products will be returned to the customer freight collect. All warranted parts that have been replaced become the sole property of SCCI.

What is NOT covered under this warranty?

This warranty shall not apply to any product that has been tampered with, improperly installed, damaged as a result of accident or neglect, improperly repaired or altered by the customer or his agent/tech, or abused resulting in broken, sheered, or fractured shafts and/or gears. This warranty shall not apply to any products damaged due to low fluid conditions, any competitive use (i.e. sled pulling or drag racing), or any commercial applications which tow weights in excess of manufacturer's GCVWR. SCCI will not warranty broken, sheered, or fractured shafts and/or drums; or any damage associated with broken shafts or drums.

SCCI will not be liable for towing charges, rental car, travel/lodging expenses or any other claims for special, indirect, or consequential damages that may arise under the provisions of this warranty.
